### **Meeting Minutes**

April 8, 2021

#### **Call To Order**

Justin Cox called to order the regular meeting of the LEPC on April 8, 2021 at 11:05 a.m. on a virtual Teams meeting.

#### **Introductions of New Members**

Elizabeth Adame, San Jacinto College, introduced herself as a guest. Hailey Newton, Air Products, introduced herself as a guest.

### **Approval of Minutes from Last Meeting**

The March meeting minutes were displayed. No objections were made to the meeting minutes. Michael Shirey, OxyVinyls, made a motion to accept the March meeting minutes. Johnny Morales, City of La Porte, seconded the motion. Vote was taken. Motion carried.

### **Approval of Treasurer's Report from the Last Month**

The total available funds as of March 11, 2021 were \$85,196.63. The total receipts received in March equaled \$48,144.80. Disbursements totaled \$29,139.09. A motion by Eddie Johanson, Kuraray, was made to accept the April budget report. Lance Hardcastle, LyondellBasell La Porte, seconded the motion. Vote was taken. Motion carried.

#### Reports

- **a. Planning Lance Hardcastle:** David Bierling, Texas A&M Transportation Institute, and his team have been conducting data collection twice a week. They will continue to work throughout the month of April and into May.
- b. Emergency Response and Communications Johnny Morales:
  - 1. Incidents
    - a) On March 14<sup>th</sup>, a small fire incident occurred at Kuraray EVAL. A Level 2 notification was issued as a courtesy, due to potential visibility of smoke and emergency vehicles. The small fire was quickly extinguished, an all-clear was issued shortly after. No chemicals involved.
    - b) On April 7<sup>th</sup>, the City of La Porte issued a Level 3, for a fire incident that occurred at HWY 225 & Independence Pkwy. The Fire Department was unaware what materials were burning and recommended a Shelter in Place (SIP) for industrial neighbors that were north of the incident. Industrials took action immediately when SIP notification was received. Once air monitoring was complete, shelter in place was lifted. Harris County Hazmat and Industrial Liaison responded. Incident is under investigation.
  - 2. E-Notify Update Dan Heiken: E-Notify & CAER Online Training is set for April 20<sup>th</sup>. Irais will send out an email to all members to sign up.
- c. Public Education & Information Denise Lee: Kristin will reach out to the school district to see if they would like to do the Baker 6<sup>th</sup> Grade Program this year. Also, Johnny is working to look at updating the Shelter in Place Video for the community. He is also working on an Emergency Preparedness Guide that will be sponsored by the LEPC, which will go out to residents in La Porte, Morgan's Point & Shoreacres by the end of May.
- **d. Training and Exercise: Jeff Suggs-** Still looking to conduct a smaller scale exercise in near future during fall.

- e. Membership Committee: Courtney Hamilton: No report.
- **f. Golf Tournament Richard Bass:** Golf Tournament will take place on October 13<sup>th</sup> at 12pm at the Bay Forest Golf Course, depending on COVID-19 conditions.
